ROPELAND CROCHET PLAYGROUNDS and accessories is a new concept in the field of the amusement industry, created to develop kids` imagination and orientation.

It encourages children crossing various levels, tunnels, and playground areas, while looking for the right path; learning balance by jumping on upper levels, swinging on the balls, climbing or just rolling in the soft mesh.

Developing a unique and proper rope for ROPELAND facilities took us almost a year until we reached the perfect combination of a robust, soft and durable rope of technical polyester.

The choice of shapes, sizes, levels, colors and obstacles are endless and can be customized by Your requests.

The first completed project opened in Bulgaria by the Black Sea in 2014, where the new playground gained enormous success and incomparable interest.

After the new product was first publicly marketed, the Company rapidly increased its production from few new installations in the first year to 38 in the second and 124 in the following year.

From there on, the success was unstoppable and the production grew exponentially.

Another major breakthrough happened in August of 2018, when ROPELAND Company received a patent for industrial design and an official recognition as an innovator and pioneer in manufacturing of crochet rope net installations for playgrounds.

The following year, ROPELAND chose Istanbul, Turkey for its second manufacturing site. The increased demand was met with the opening of another manufacturing site in Bulgaria in 2022.

Currently, the ROPELAND products are sold out on four continents."

### MAINTENANCE MANUAL

### **REGULAR MAINTENANCE INSTRUCTIONS**

For playgrounds subject to heavy use or vandalism, daily inspection of this type might be necessary.

Examples of visual and operational inspection points are: cleanliness, equipment ground clearances, ground surface finishes, exposed foundations, sharp edges, missing parts, excessive wear (of moving parts) and structural integrity.

DAILY inspection of the facility and its safety zone for cleanliness. Please, clean with watered clothes /or water and soap/, if any dirt/stains appear.

DAILY inspection of the facility and its safety zone for sharp objects or lost items inside.

#### DAILY inspection of the facility for torn yarns or ropes. In

case of broken ropes due to some acts of vandalism /or any other reason/ - please, close the facility for use, take detailed pictures and contact the manufacturer/dealer immediately for further instructions!

### WEEKLY

inspection of the integrity of winches/lever chains and their even lifting /tensioning, if necessary.

WEEKLY inspection of wear equipment components /crochet partition walls, "pockets", inside crochet columns/, ball-swings, caterpillars, floor seats, etc.

After end of season /or in case you see some dirt/ spray the facility with a 3:1 water + soap solution. Rinse with water and let it dry for 24-48 hours. Repeat during the active season, if necessary. Do not use chemically active preparations

Disinfection: spray the equipment with a solution of water and kids-friendly disinfectant, in a ratio of 3:1. Do not rinse. Let it dry for 24 hours. Repeat MONTHLY

### MONTHLY ACTION REQUIRED

Inspect the foundation and the bearing structure of the equipment for corrosion and formation of deformations. Adjust, repair and replace, if necessary.

In countries with low temperatures during the winter season and heavy snowfalls, for all OUTDOOR Ropelands, we recommend removing and storing the facility for the winter season.

In case the facility is also used during the winter season please, add a tent above it and plow the snow off it .

- In countries with temperatures above 35 degrees Celsius during the active seasons of Ropeland and abundant sunny days, we recommend that you provide a light-colored protective sunshade above the facility. Otherwise you risk about 30% fading of some of the primary colors of the rope approximately after 1 year of usage. Active play of kids in temperatures of 35 degrees Celsius or higher may cause dehydration of users

### Flammability

To avoid the risk of fire and associated hazards, materials known to produce surface flash shall not be used. In case of fire - follow the instructions of the hall, use fire extinguisher and call the fire department immediately.

All the grids in the Ropeland products are more than 10 cm2 and the rope frame thereof does not exceed 25% of the total net surface.

**WARNING:** Take care, in relation to specific hazards to children, during incomplete installation or during maintenance.





END OF SEASON We recommend removing the facility and storing it in a dry and ventilated place after the end of the season. Applies to Outdoor facilities.

### INSTRUCTION **TABLE**

Please note: All regular maintenance instructions mentioned here are only recommendable. In accordance with any of the below circumstances, according to each specific location, intensity of use, social environment, vandalism or climatic features, etc., they are recommended to be adapted by the Operator / Owner of the facility.

Enter the facility trough the "pockets", climb up to the "labyrinth" and use the holes to reach the top level of the facility.



Children 3 - 4.99 years old are not allowed in the facility without parental / operator supervision.



Sharp objects and accessories into the play area are strictly forbidden due to a risk of injury and damage of both users and the facility.



Using Ropeland with shoes is prohibited.



Using Ropeland bare feet is prohibited due to hygienic reasons.



Entry with jewelry is prohibited, as it can get stuck on the net and cause an injury.



Eating and drinking inside Ropeland is prohibited!












